(TAX-EXEMPT STATUS OF NON-PROFIT CNMI CORPORATIONS)

I, the undersigned authorized representative of the non-profit corporation named below, have, on the date set forth below, received from the Registrar of Corporations approved Petition, Non-Profit Charter and the Bylaws for this non-profit corporation, and acknowledged receipt of a copy of this Notice advising that the non-profit corporate status of this entity does not grant to the non-profit corporation a tax-exempt status since such recognition can only be granted by the Revenue and Tax Division of the CNMI Secretary of Finance Office after this non-profit corporation has filed appropriate documents seeking tax-exempt status with the Revenue and Tax of the Secretary of Finance Office. I further acknowledged that representatives of this non-profit corporation are aware that unless and until tax exempt status is granted to this non-profit corporation, the corporation must file income tax returns as any "for profit" business in the CNMI; and, no contribution made to the non-profit corporation listed below is "tax deductible" to the donor unless and until such tax-exempt status is granted to this non-profit corporation. I further acknowledged that the initial report must be delivered to the Registrar of Corporations within 60 days after the corporation was incorporated and authorized to transact business and that subsequent annual reports must be delivered to the Registrar of Corporations between January 1 and March of the following years, pursuant to P. L. 10-7, now codified at 4 CMC §4693.
